*NOTE GAS TREATMENT CENTRE OPERATOR:

- (A) Entry into the Power Engineer learner system requires minimum grade 12 education or proof of successful completion of the 4th class BCIT or other accredited academic Correspondence Course and for selection purposes, all of these educational attainments will be considered equal.
- (h) Employees who cannot achieve the 4th class level in the time frame required, (eighteen (18) months) will not be eligible for a position within the job classification. If the employee is not successful they will be reassigned to another job opening.
- (i) Employees who cannot achieve the 3rd class level in the time frame required, (thirty-six (36) months after achieving the full 4th class certification) will not be eligible for a position within the job classification. If an employee is not successful they will be reassigned to another job opening, as per CLA 11-LU-#2.
